Containing four hundred acres with allowance and all the improvements hereliatements and appurtenances thereunto belonging young apple and peach trees and one stack oh hay only excepted I the said Jeremiah Meeks doth grant bargin sell release and confirm to the above named MeCandlessess and doth warrant and defend the above named improvement from all my heirs assigns or from my person persons laying any claim or claims unto the said track of land and I do hereby deliver all my rights title claim and interest of in to the said track of land with all the appurtanences belonging to them and their heirs or assigns forever subject nevertheless the residue of the purchase money fuit rent due and to become due to honourable the proprietors or lord or lords of the soil only excepted.
